

## TESTPAP (PI)

Does the medical record contain the report of a Pap test performed for this patient within the past five years?

- 1. Pap test performed by VHA
- 3. Pap test performed by private sector provider
- 6. Hysterectomy or congenital absence of a cervix
- 7. All Pap test reports within the past five years note sample was inadequate or that "no cervical cells were present"
- 98. Patient refused all Pap tests
- 99. No documentation Pap test performed



\* This measure is written as "Past three years: During the period starting the 1st day of the 36th month prior to study interval beginning date extending to last day of the month under study" so do not use the standard one month = 30 days rule.

### PAPDT (PI)

Enter date of the most recent Pap test performed during the past three years.

### HPVTEST (PI)

During the past five years, does the medical record contain the report of a cervical human papillomavirus (HPV) test performed for this patient?

- 1. HPV test performed by VHA
- 3. HPV test performed by private sector provider 99. No documentation HPV test performed

### **HPVTSTDT** (PI)

Enter the date of the most recent cervical HPV test performed during the past five years.

#### NOCASCRN (PI)

During the past five years, did the patient's primary care physician/APN/PA document that he/she does not believe that this patient will experience a netbenefit from cancer screening, because of one or both of the following:

- Patient's life expectancy is < 5 years because of diagnosesor clinical factors (as specified in the progress note)
- Patient could not tolerate the further work-up or treatment (if the screen was positive) because of co-morbidities (as specified in the progress note)
