


- 1. Home
- Assisted Living Facilities (ALFs) includes assisted living care at nursing home/facility
- Court/Law Enforcement includes detention facilities, jails, and prison
- Home includes board and care, domiciliary, foster or residential care, group or personal care homes, retirement communities, and homeless shelters
- Home with Home Health Services
- Outpatient Services including outpatient procedures at another hospital, outpatient Chemical Dependency Programs and Partial Hospitalization
- 2. Hospice Home (or other home setting as listed in #1 above)

### **PTSTATDC**

- the patient eloped and was discharged

### **PSYMEDC**

Enter the documented number of scheduled antipsychotic medications prescribed for the patient at discharge.

### WHYMOR1

Is there documentation in the medical record of <u>appropriate justification</u> for discharging the patient on two or more routine antipsychotic medications?

- 1. The medical record contains documentation of a history of a minimum of three failed multiple trials of monotherapy
- The medical record contains documentation of a recommended plan to taper to monotherapy due to previous use of multiple antipsychotic medications OR documentation of a cross-taper in progress at the time of discharge
- 3. The medical record contains documentation of augmentation of Clozapine
- 4. Documentation of a justification other than those listed in options 1-3
- The medical record does not contain documentation supporting the reason for being discharged on two or more antipsychotic medications OR unable to determine from medical record documentation
