TESTPAP (PI)

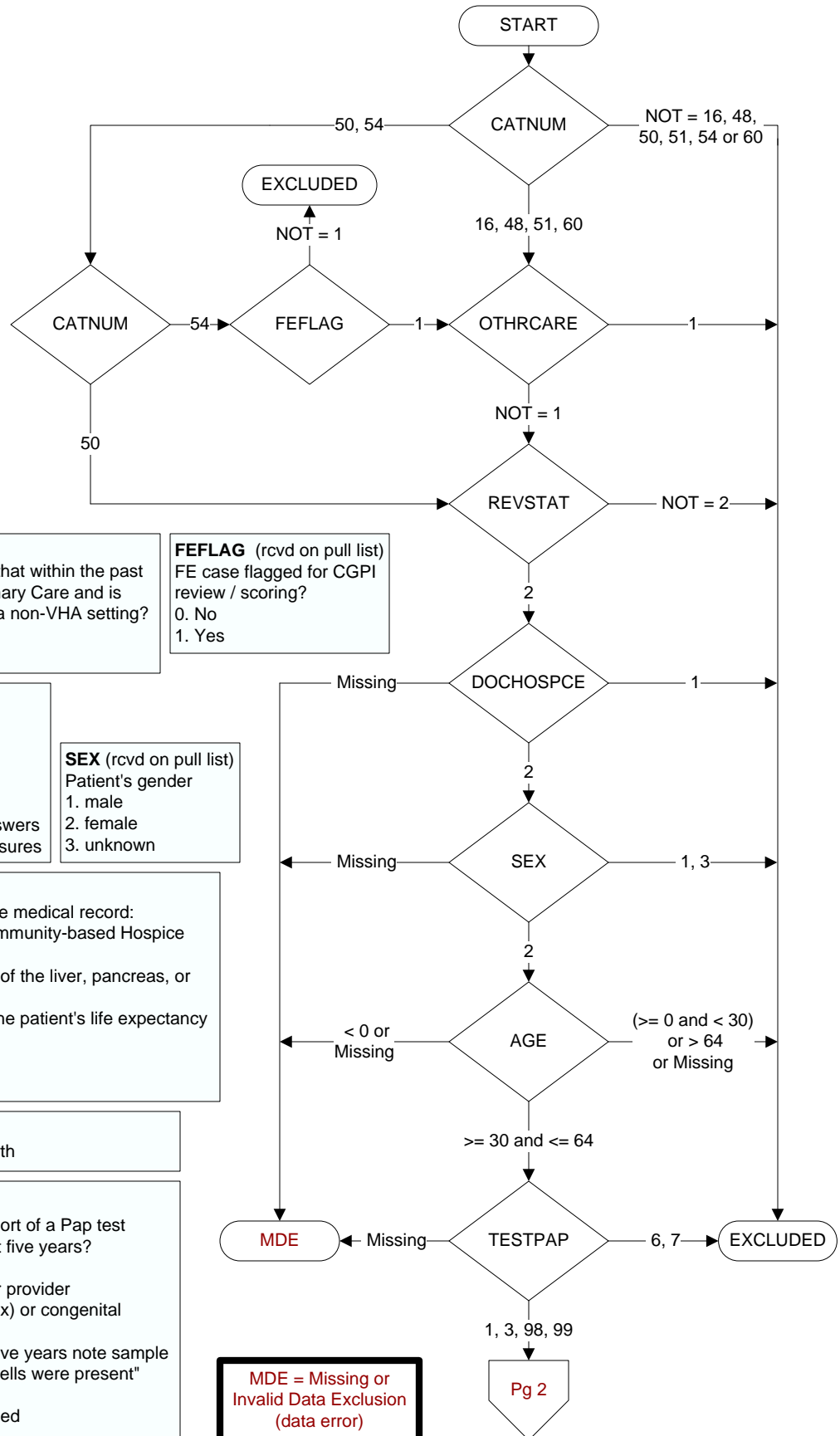

* This measure is written as "Past three years: During the period starting the 1st day of the 36th month prior to study interval beginning date extending to last day of the month under study" so do not use the standard one month = 30 days rule.
