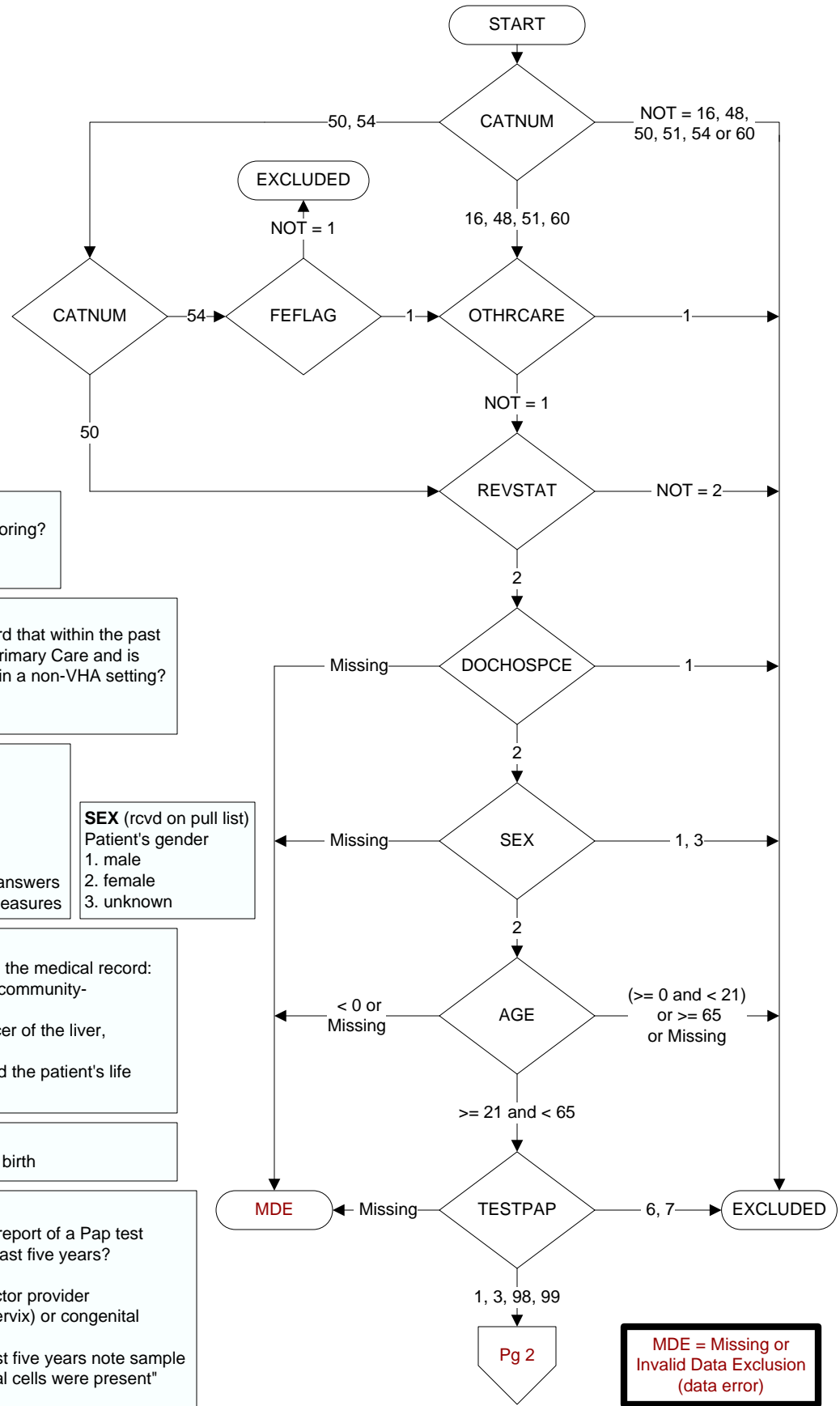

AGE (Calculated field)

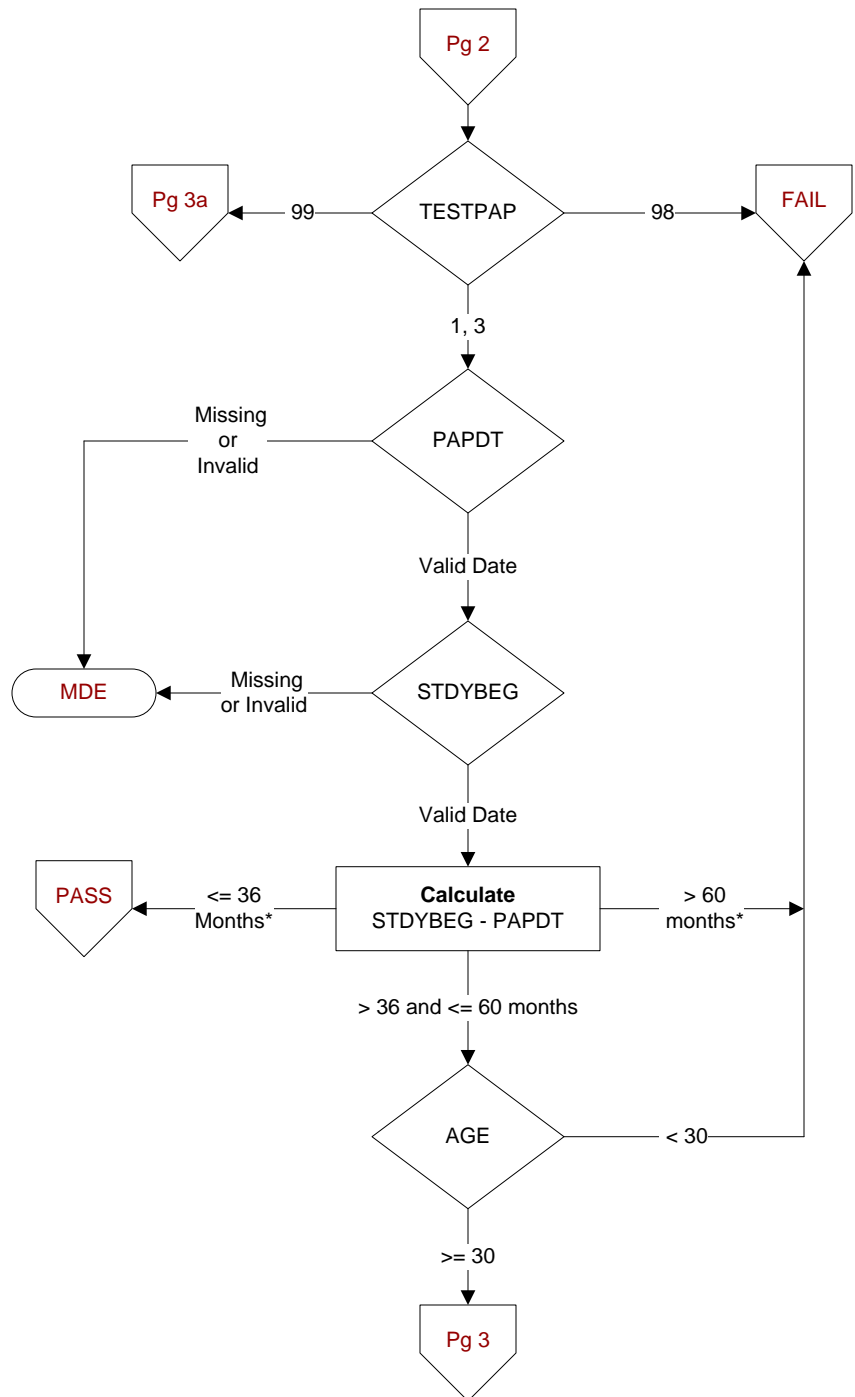
NEXUS clinic vist dt - patient date of birth

TESTPAP (PI)

Does the medical record contain the report of a Pap test performed for this patient within the past five years?
 1. Pap test performed by VHA
 3. Pap test performed by private sector provider
 6. Hysterectomy (with no residual cervix) or congenital absence of a cervix
 7. All Pap test reports within the past five years note sample was inadequate or that "no cervical cells were present"
 98. Patient refused all Pap tests
 99. No documentation Pap test performed

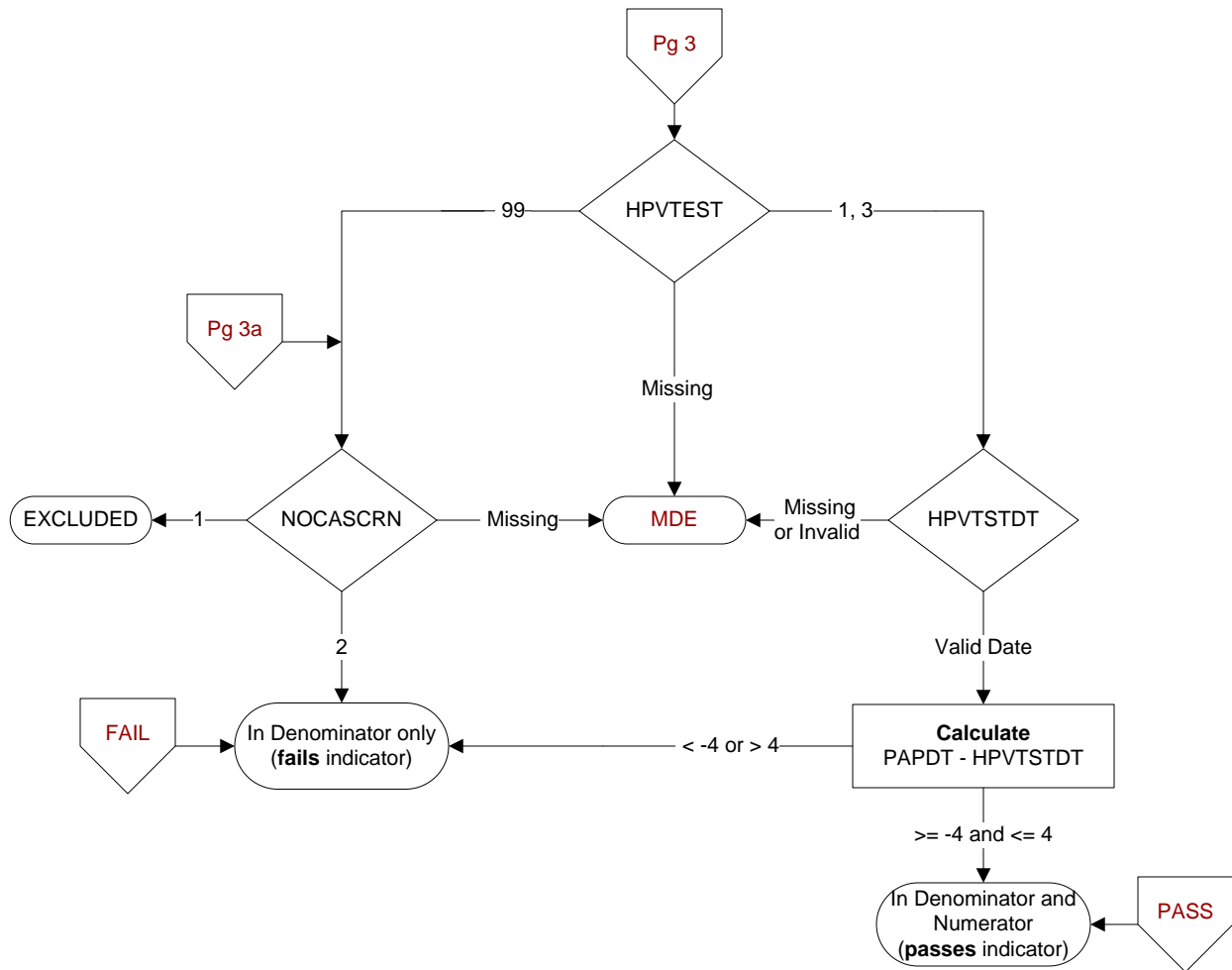


* This measure is written as "Past three years:

**HPVTEST (PI)**

During the timeframe from (computer to display papdt – 4 days to papdt + 4 days), does the medical record document a cervical human papillomavirus (HPV) test was performed for this patient?

HPVTSTD (PI)

Enter the date of the most recent cervical HPV test performed.

NOCASCNRN (PI)

- Patient's life expectancy is < 5 years because of diagnoses or clinical factors (as specified in the progress note)
