


TESTPAP (PI)

Does the medical record contain the report of a Pap test performed for this patient within the past five years?

 7. All Pap test reports within the past five years note sample was inadequate or that "no cervical cells were present"


MDE = Missing or Invalid Data Exclusion (data error)

During the period starting the 1st day of the 36th

so **do not use the standard one month = 30
days rule.**
