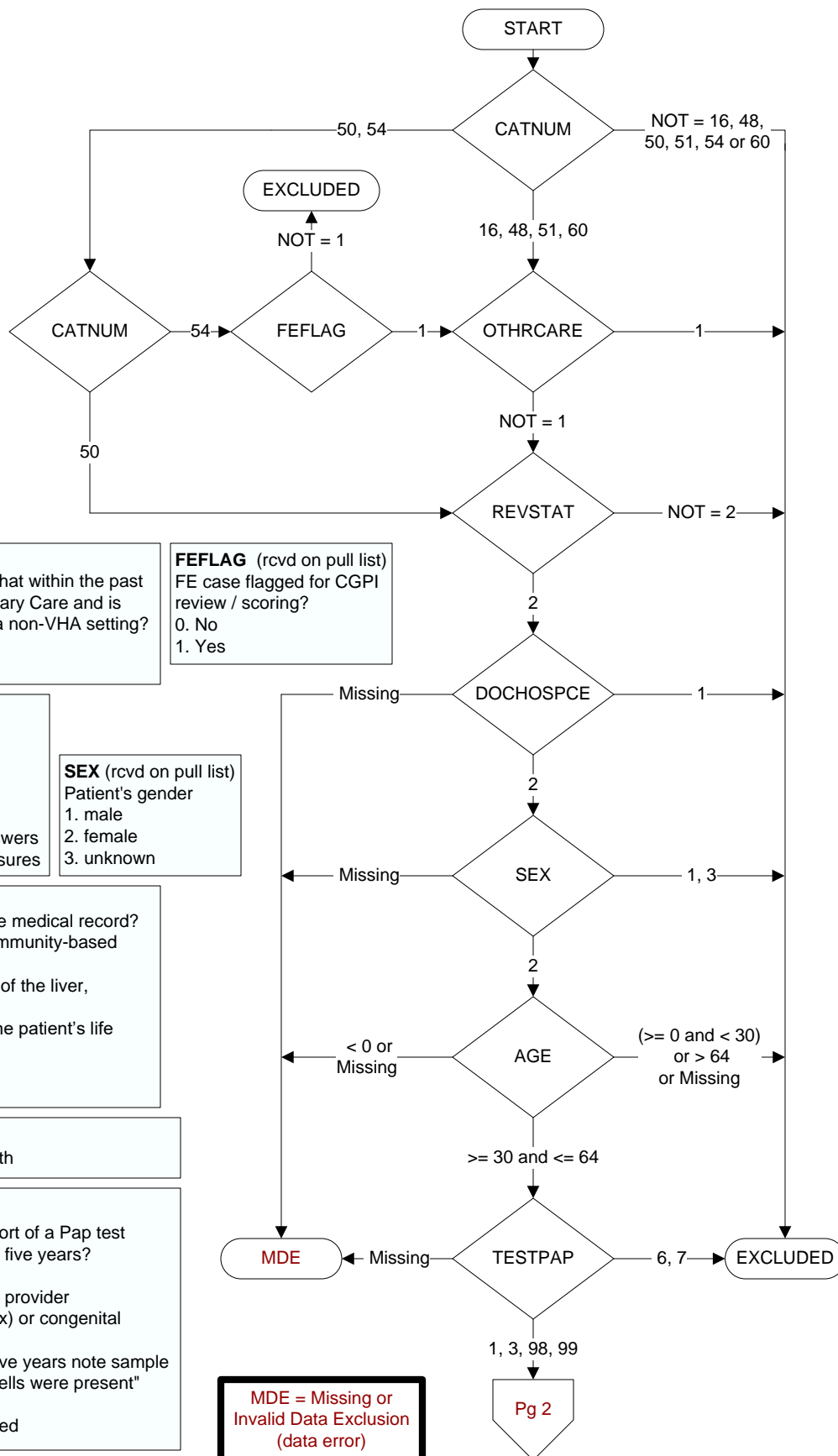

TESTPAP (PI)

Does the medical record contain the report of a Pap test performed for this patient within the past five years?
