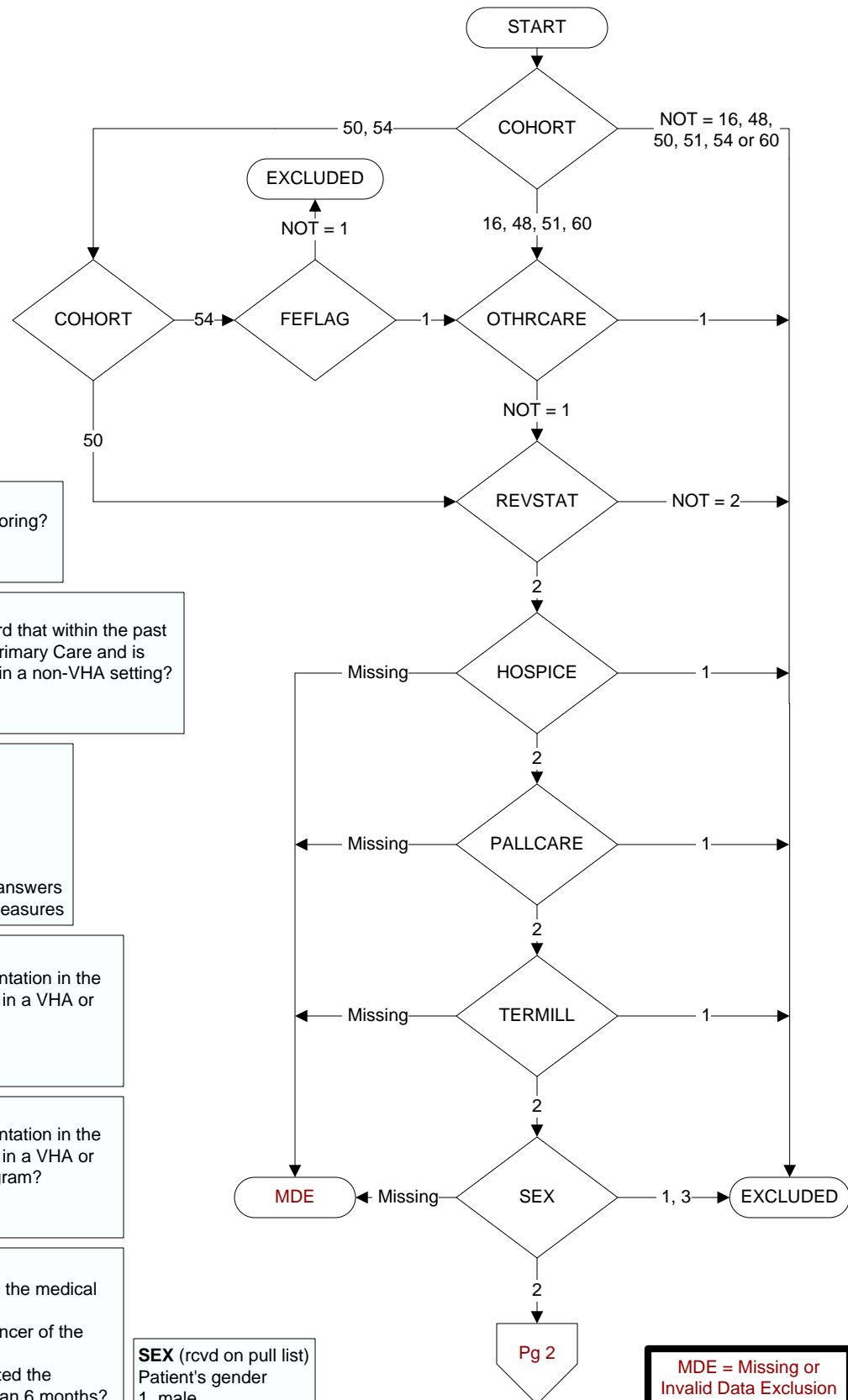

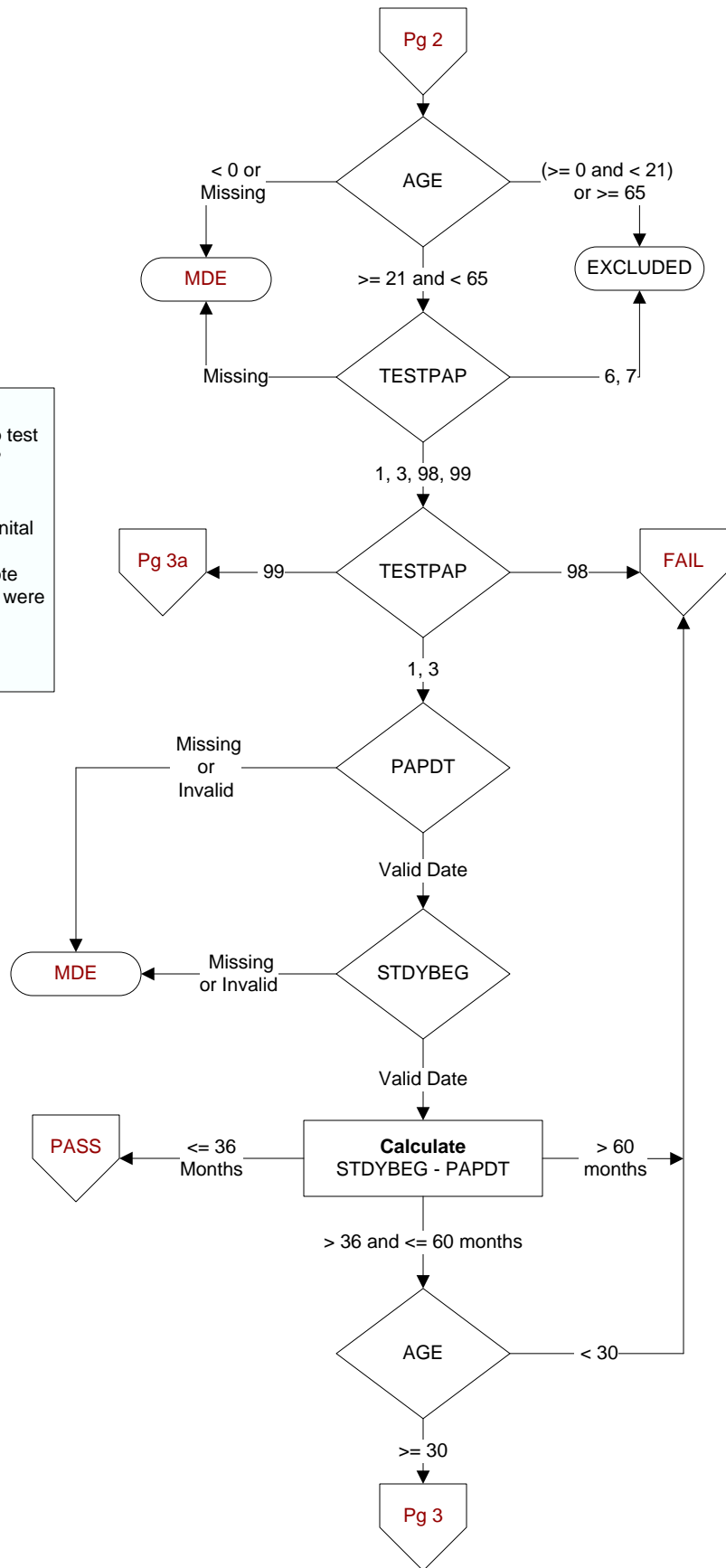

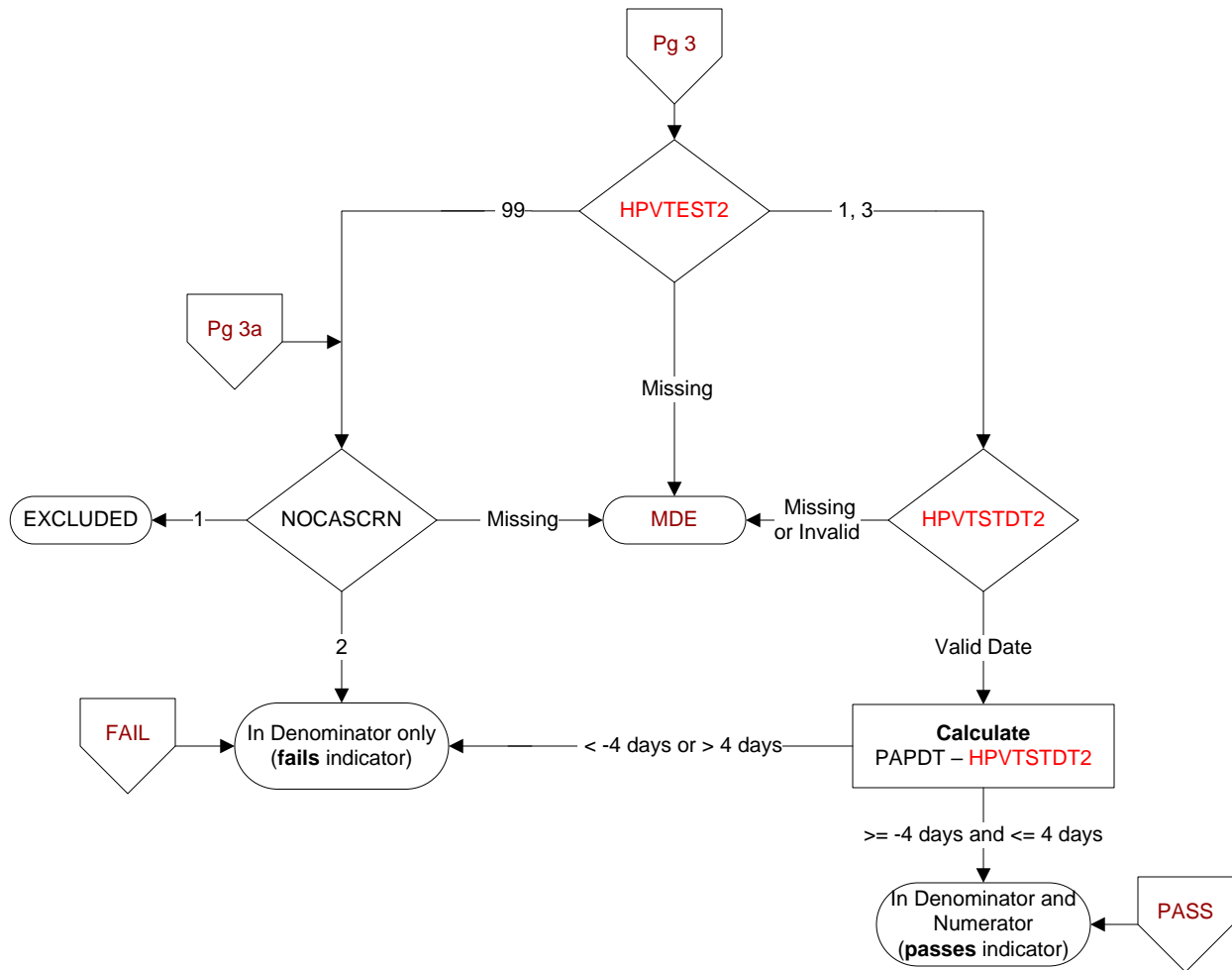
1. Pap test performed by VHA
