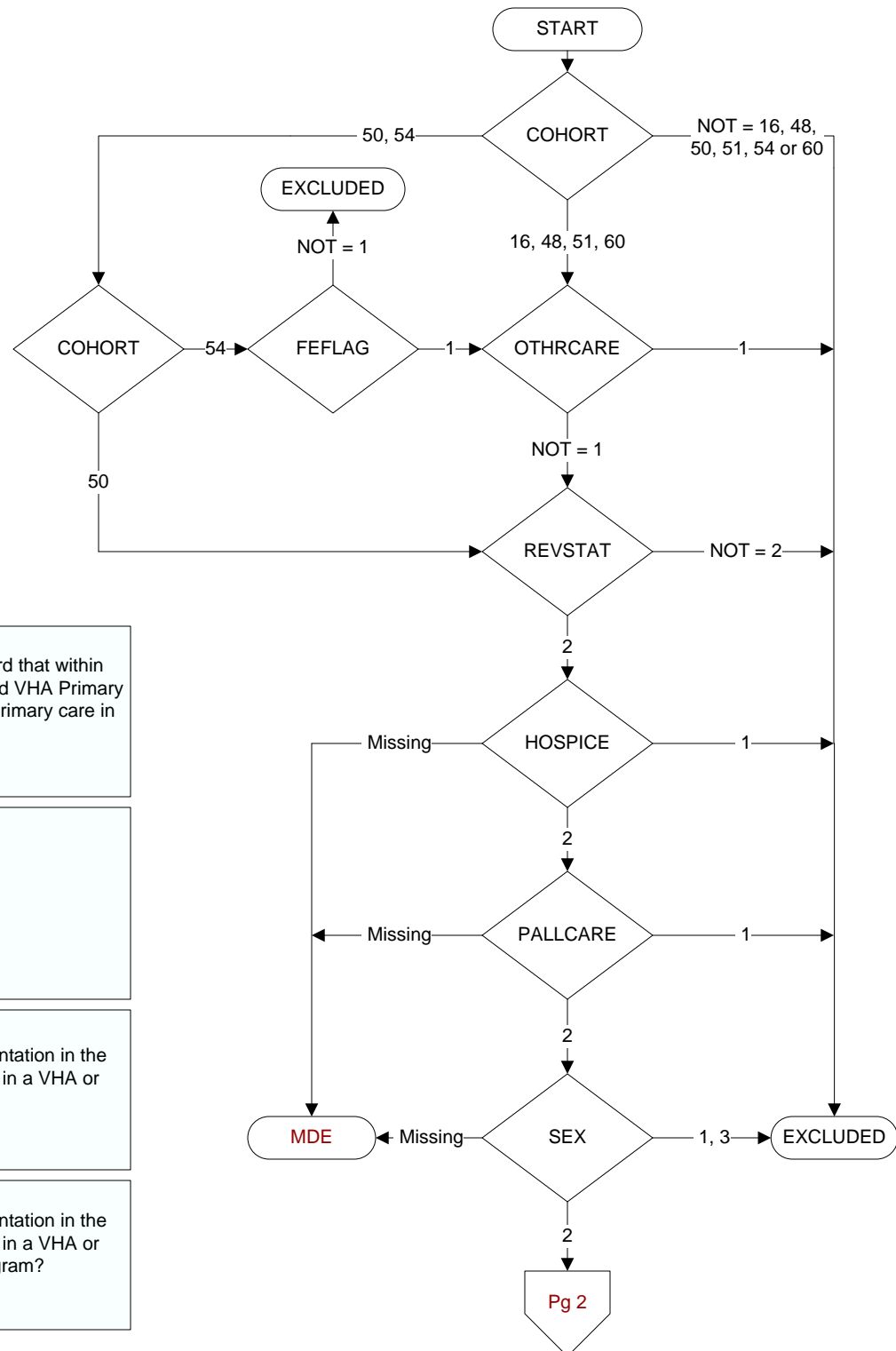

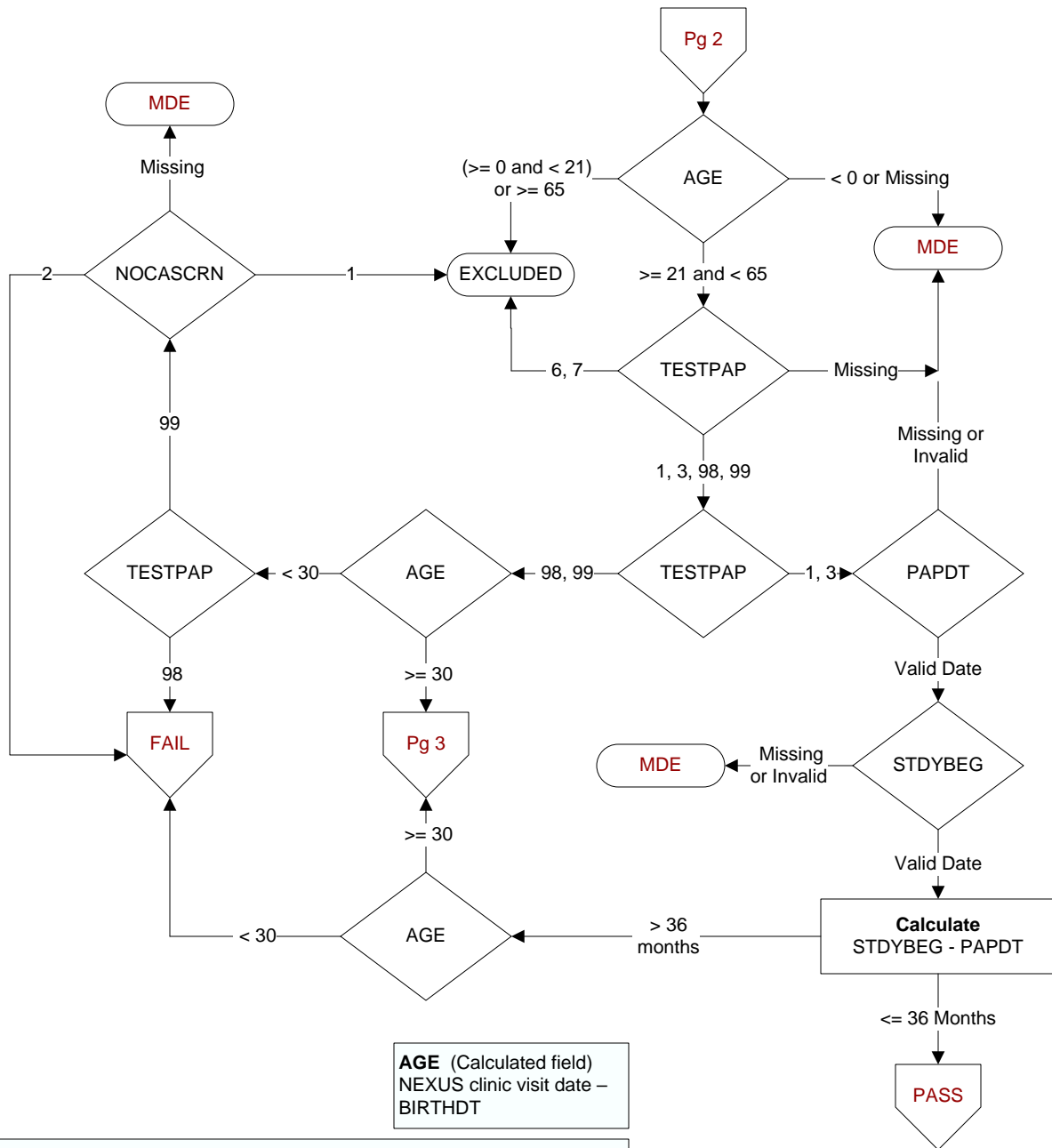

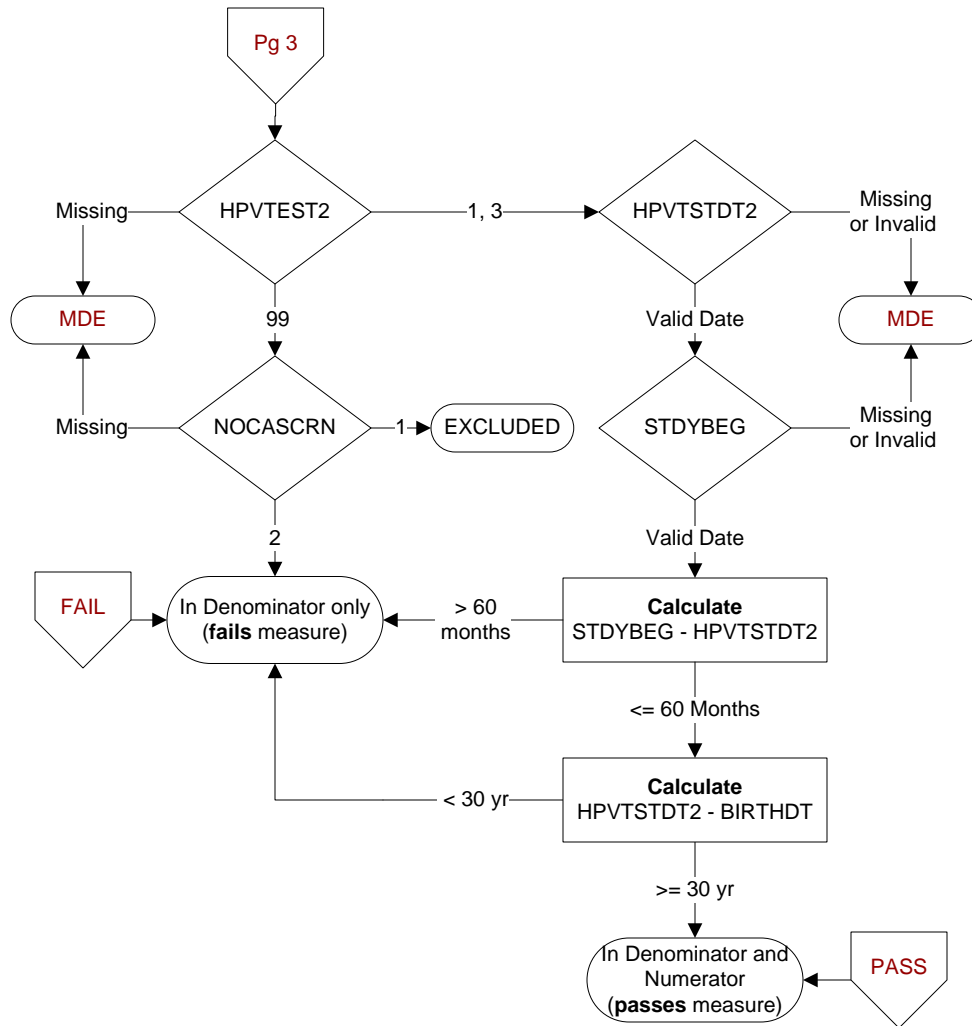

**PAPDT** (PI)  
Enter the collection date of the most recent Pap test performed during the past five years.

#### NOCASCNR (PI)
