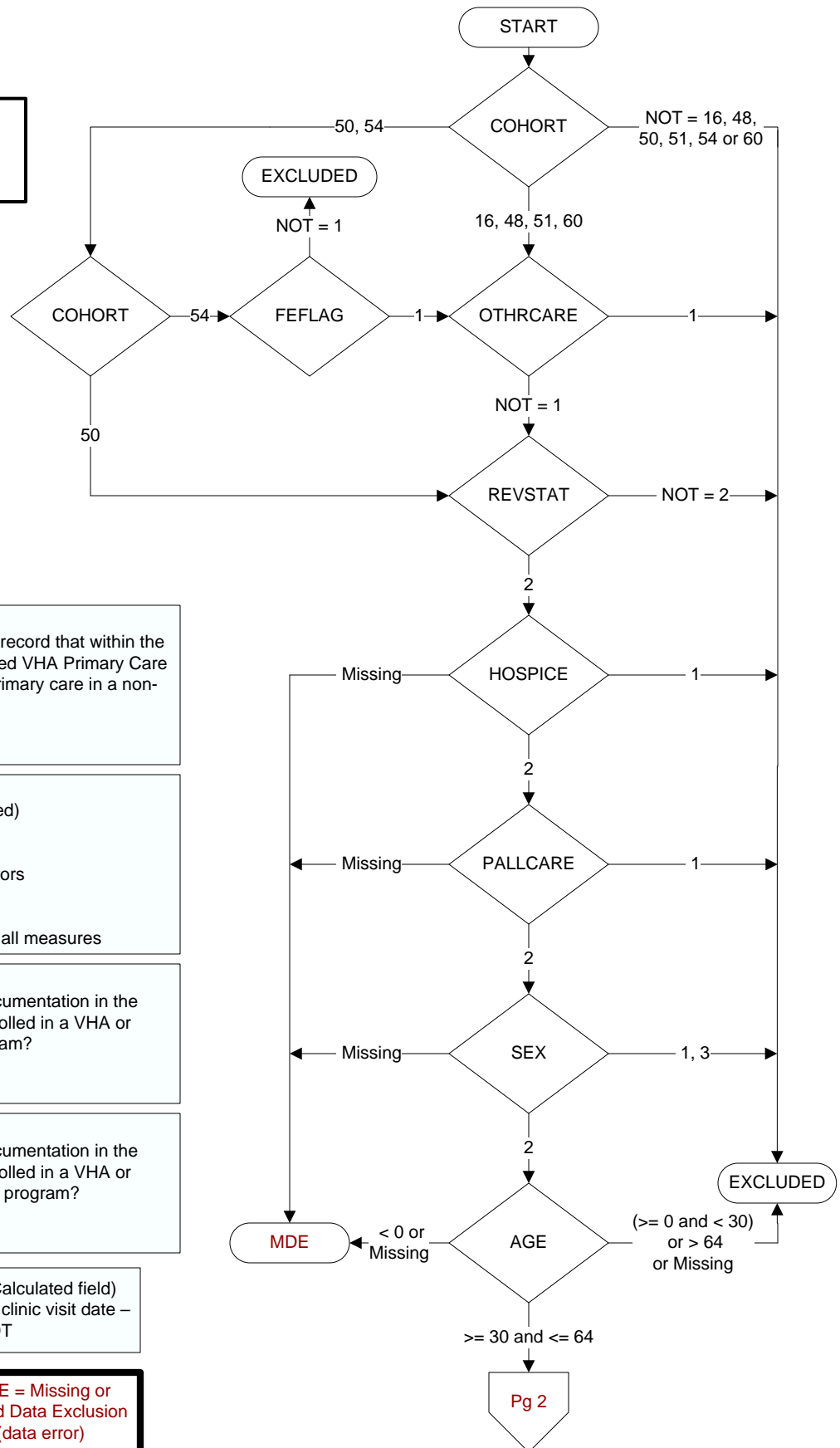

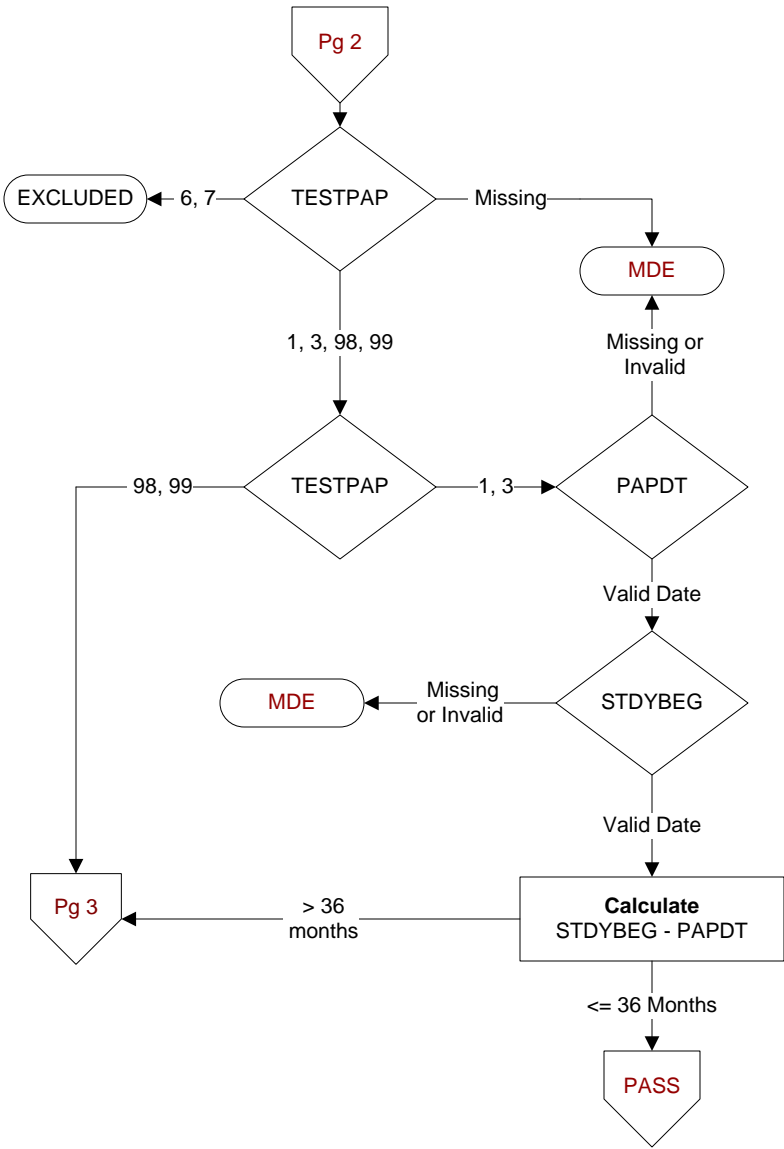

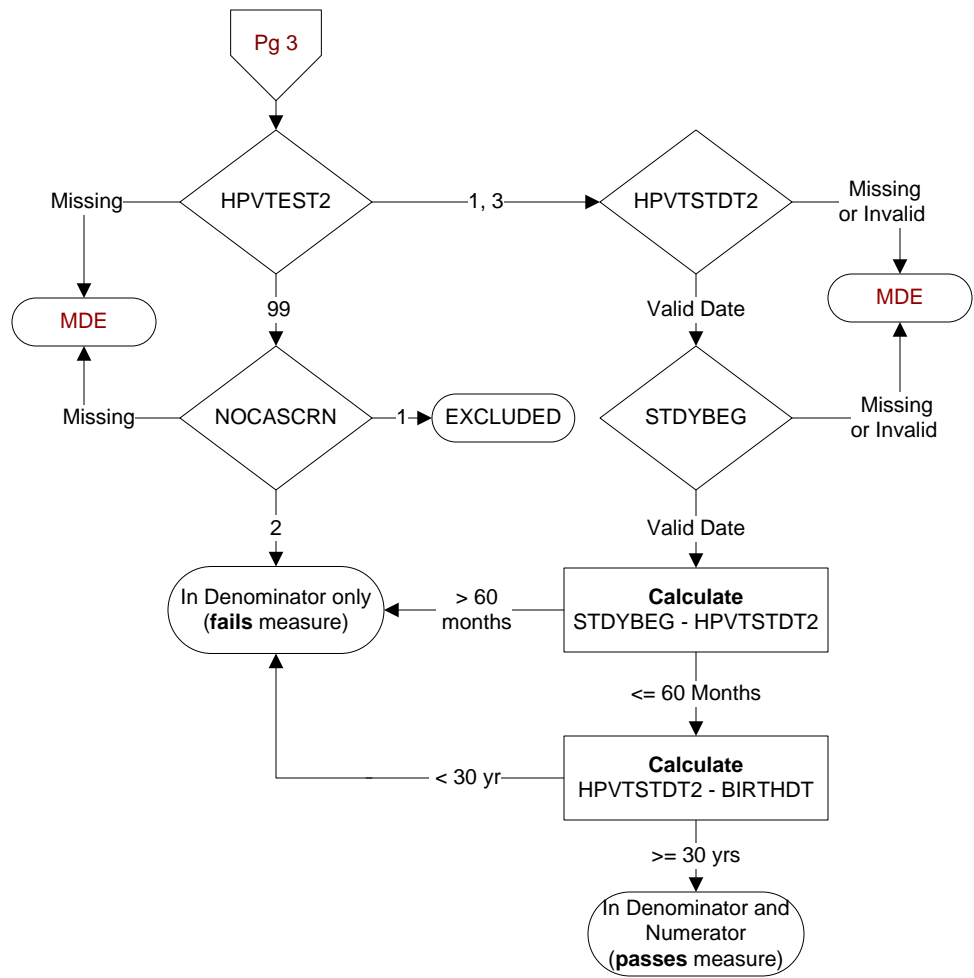


TESTPAP (PI)
Does the medical record contain the report of a Pap test performed for this patient within the past five years?

- 1. Pap test performed by VHA
- 3. Pap test performed by private sector provider
- 6. Hysterectomy (with no residual cervix) or congenital absence of a cervix
- 7. **All** Pap test reports within the past five years note sample was inadequate or that "no cervical cells were present"
- 98. Patient refused all Pap tests
- 99. No documentation Pap test performed

Study Interval begin date

PAPDT (PI)
Enter the collection date of the most recent Pap test performed during the past five years.



HPVTEST2 (PI)

Within the past 5 years, was a cervical hrHPV/HPV test performed?
