




**ILLFLAG** (rcvd on pull list)

**DEMEDS** (Validation module)

**NOCASCRN** (PI)

 -- Patient's life expectancy is < 5 years because of diagnoses or clinical factors (as specified in the progress note)  
 -- Patient could not tolerate the further work-up or treatment (if the screen was positive) because of co-morbidities (as specified in the progress note)
